Safe Bag signs a 7 years contract with RIOgaleão - Rio de Janeiro International Airport

Milan – 3 July 2018 - Safe Bag S.p.A. (AIM Italia, ticker SB), world leader in the services of protection and tracking of baggage for the airport passengers, communicates that it signed a contract for 7 years for the supply of its own integrated offer of services for the travellers at RIOgaleão - the International Airport of Rio de Janeiro.

Such contract, following a period of test in the last quarter of 2017 where Safe Bag had the opportunity to present its concept and services, will have a 7-year duration starting from beginning of July.

RIOgaleão is among the most important airports in Brazil, with around 16 Million passengers in 2017.

“We are very proud that, after a period of test, the airport of Rio de Janeiro has selected us as its long term’s partner – **Alessandro Notari** declares, **CEO of Safe Bag** - because it allows us to continue pursuing our long-term development strategy in South America that is already started with our win at Lima Airport”.

Leandro Dantas, RIOgaleão’s Head Comercial, believes that the arrival of Safe Bag is an important mark on the airport’s strategy: “As RIOgaleão has become an airport with international standards, we have to make sure the passenger can count on high quality options. Knowing that Safe Bag has the expertise for this kind of service, in airports all around the world, we are proud and happy to bring the company to work together with us. This is one more step towards offering the tourists the best alternatives in terms of globally recognized services”.
