Safe Bag: the subsidiary Wrapping Service LLC renews its contract with Domodedovo airport (Moscow) - Russia; the subsidiary PackandFly signs a temporary agreement with the airport of Puerto Montt (Chile)

Milan – 1 October 2018 - Safe Bag S.p.A. (AIM Italia, ticker: SB), the global leader in airline passenger baggage protection and tracking services, has announced that its subsidiary Wrapping Service LLC - acquired during the PackandFly operation - undersigned a one-year contract renewal for the supply of its integrated service offer for travelers at Domodedovo International Airport in Moscow, Russia.

Moscow's Domodedovo Airport is Russia's most important airport, with circa 15.3 million passengers in 2017.

It should also be noted that the subsidiary PackandFly Group OU – which was also acquired during the PackandFly operation - has signed a temporary one-year agreement for the supply of its integrated service offering for travelers at the International Airport of Puerto Montt, Chile.

Puerto Montt Airport, with over 1 million passengers in 2017, is one of the most important tourist airports in southern Chile, and serves as a gateway to Patagonia.

Safe Bag, founded in 1997 by Rudolph Gentile and guided by the CEO Alessandro Notari, is the leader in the luggage protection and tracing service for airport passengers, through an integrated portfolio of solutions for passenger safety and comfort: luggage wrapping; traceability, reimbursement in the event of loss or damage to luggage, travel products and accessories. It has been listed on the AIM segment of Borsa Italian since September 2013.

Safe Bag, with headquarters in Gallarate (VA), has around 600 collaborators at global level, with around 5 million customers a year, and is present in the airports of Italy, France, Portugal, Switzerland, USA, Canada, Brazil, Poland, Russia, Lithuania, Latvia, Estonia, Kyrgyzstan, Thailand and the Philippines with 150 points of sale.
