### **Safe Bag: the subsidiary Wrapping Service LLC has signed a 7-year agreement to provide services for Terminal B of Sheremetyevo Airport (Moscow) – Russia**

*Milan – 28 November 2018* - Safe Bag S.p.A., world leader in luggage protection and tracing services for airport passengers announces that its subsidiary Wrapping Service LLC, acquired during the PackandFly operation, has signed a 7-year agreement to provide its integrated offer of services for passengers at Terminal 8 of Sheremetyevo international Airport, Moscow, Russia.

The subsidiary, which has already been operating at Terminals I D, E, F of the same airport with a long term agreement, will also be present, from 5th December 2018, at Terminal B, where the national flights of the Russian national airline Aeroflot are based.

Moscow Sheremetyevo Airport is the most important airport in Russia, with around 40 million passengers in 2017, 15 million of whom passed through Terminal B.

“Terminal B of Sheremetyevo Airport is, in fact, an airport within an airport with very high penetration rates for our services – declares **Rudolph Gentile, President of Safe Bag** – an extra arrow in our bow which confirms the strength of our Industrial Plan even before it has been approved”.

“After completing the PackandFly and Care4 Bag acquisitions, the virtuous path of organic growth, the most important aspect of our development strategy, takes off again – declares **Alessandro Notary, CEO of Safe Bag**”.

**Safe Bag**, founded in 1997 by Rudolph Gentile and guided by him together with the CEO Alessandro Notary, is the leader in the luggage protection and tracing service for airport passengers, through an integrated portfolio of solutions for passenger safety and comfort: luggage wrapping; traceability, reimbursement in the event of loss or damage to luggage, travel products and accessories.

It has been listed on the AIM segment of Borsa Italiana since September 2013.

Safe Bag, with headquarters in Gallarate (VA), has around 600 collaborators at global level, with around 5 million customers a year, and is present in the airports of Italy, France, Portugal, Switzerland, USA, Canada, Brazil, Chile, Poland, Russia, Lithuania, Latvia, Estonia, Kyrgyzstan, Thailand and the Philippines with 150 points of sale.
