Safe Bag: the subsidiary Wrapping Service LLC wins a 7-year contract for Terminal C of Sheremetyevo Airport (Moscow) – Russia

Milan – 29 March 2019 – Safe Bag S.p.a. (AIM Italia, ticker: SOS), world leader in luggage protection and tracing services for airport passengers, announces that its subsidiary Wrapping Service LLC, acquired during the PackandFly operation, has received confirmation that it has won a 7-year contract to supply its own integrated offer of services for passengers at Terminal C of Sheremetyevo International Airport in Moscow, Russia.

The subsidiary, already operating under a long-term agreement at Terminals B, D, E and F of the same airport, shall therefore also be operating, from 1st January next year, at Terminal C, recently awarded the title of “5-Star Terminal” by the British association SkyTrax, specialising in reviewing airports and airlines.

Moscow Sheremetyevo Airport is the most important Russian airport, with around 40 million passengers in 2018, 18 million of whom passed through Terminal C. Following the opening of Terminals C1 and C2, planned for the end of the year, the transit capacity of Sheremetyevo will increase to 100 million passengers.

“Sheremetyevo Airport’s Terminal C is actually an airport within an airport with very high penetration rates for our services – declares **Alessandro Notari, CEO of Safe Bag** – an extra arrow in our bow which confirms the accuracy of our Industrial Plan approved last November”.

Safe Bag, founded in 1997 by Rudolph Gentile and guided by him together with the CEO Alessandro Notari, is the world leader in the luggage protection and tracing service for airport passengers, through an integrated portfolio of solutions for passenger safety and comfort: luggage wrapping; traceability, reimbursement in the event of loss or damage to luggage, travel products and accessories.

The company has been listed on the Italian Stock Exchange Borsa Italiana –AIM segment – since September 2013.

Safe Bag, with headquarters in Gallarate (VA), has around 600 collaborators at global level, with around 5 million customers a year, and is present in the airports of Italy, France, Portugal,

Switzerland, USA, Canada, Brazil, Poland, Russia, Lithuania, Latvia, Estonia, Kyrgyzstan, Thailand and Philippines with around 150 points of sale.
