**Safe Bag signs the contract at Calgary International Airport (Canada)**

*Milan, 2 May 2019.* **Safe Bag S.p.A** – world leader in luggage protection and tracing services for airport passengers announces that its subsidiary Safe Bag Canada Inc. has today signed a 7-year agreement to supply its own integrated offer of services for travellers at Calgary International Airport – Canada.

Business is expected to start by 5 May.

With around 17.3 million passengers in 2018, with a 5.7% growth in January 2019 compared with the same month of 2018, Calgary International Airport is the fourth largest Canadian airport (after Toronto, Vancouver and Montreal).

“We continue to grow also internally – declares **Rudolph Gentile, Chairman of Safe Bag** – but recruitment of the new CEO Giuseppe Pasetti traces a clear growth strategy for our future through M&A international operations”.

**Safe Bag**, founded in 1997 by Rudolph Gentile and guided by him together with the Vice Chairman Alessandro Notari and the CEO Giuseppe Pasetti, is the world leader in the luggage protection and tracing service for airport passengers, through an integrated portfolio of solutions for passenger safety and comfort: luggage wrapping; traceability, reimbursement in the event of loss or damage to luggage, travel products and accessories.

The company has been listed on the Italian Stock Exchange Borsa Italiana –AIM segment – since September 2013.

Safe Bag, with headquarters in Gallarate (VA), has around 600 collaborators at global level, with around 5 million customers a year, and is present in the airports of Italy, France, Portugal, Switzerland, USA, Canada, Brazil, Poland, Russia, Lithuania, Latvia, Estonia, Kyrgyzstan, Thailand and Philippines with around 160 points of sale.
