TraWell Co: the subsidiary Wrapping Service LLC signs a strategic agreement with the Renova Group for the supply of its services within the next year in seven airports in the Russian Federation, and inaugurating the opening at the first international airport of Nizhniy Novgorod.

Milan, 18 December 2019 – SosTravel.com S.p.A. (AIM Italia, ticker: TWL), a world leader in baggage protection and tracking services for airport passengers, announced that its subsidiary Wrapping Service LLC, acquired during the PackandFly operation, has signed an agreement lasting three years for the supply of its integrated offer of services at Nizhniy Novgorod International Airport (GOJ) - one of the seven airports of the most dynamic and rapidly developing airport groups in the Russian Federation - under the supervision of the management company "Airports of Regions", a member of the largest Russian holding company - «Renova Group».

At the same time, an agreement was reached on a strategic partnership which provides for the gradual stipulation of contracts with the remaining airports of the Group. In the near future, Wrapping Service LLC will start working in the airports of Ekaterinburg (SVX), Samara (KUF), Rostov (ROV), Saratov (GSV), Petropavlovsk Kamchatskiy (PKC), Noviy Urengoy (NUX). The Group's total passenger traffic exceeds 16,000,000 passengers per year.

"We are proud to announce the additional success of our partner, Alexander Fedoseev, who continues to expand our Group in the Russian Federation, a market with very high penetration rates of our services and exponential growth - declared **Alessandro Notari, CEO of TraWell Co**".

"I thank my partners for their support and trust. We never rest on our laurels, and therefore by the end of this year we will open another new store at Orenburg Airport (REN)" - stated **Alexander Fedoseev, CEO of Wrapping Service LLC**.

"We close the year with an important commercial agreement - declared **Rudolph Gentile, Chairman of TraWell Co** -. Our federal model - due to shareholders such as Alexander Fedoseev - provides us with a widespread commercial presence and expansion even within remote geographical areas. We therefore hope - continues Gentile - that the other partners with whom we are meeting for discussions will soon be able to join our family".
