**TraWell Co wins the tender at Athens International Airport (Greece)**

Milan– February 10, 2020 - TraWell Co S.p.A. (AIM Italia, ticker: TWL) announces that its subsidiary Care4Bag has signed an agreement for a period of 5 years (with 2 more years possible extension) for the provision of its own integrated offer of services for travellers at the Athens International Airport.

Athens International Airport is a strategic airport for the whole Eastern Mediterranean / Balkans regions. The airport manages approximately 25,6 Million passengers in total in 2019, up 6% compared to 2018; these numbers are expected to increase significantly thanks to the expansion plan underway and that will be completed by end 2020.

Care4Bag, already operating for 7 years at Athens Airport with baggage wrapping and storage services, gets the new contract by confirming the recognition by the Airport of the excellent quality of service and performance in continuous growth.
