EXERCISE OF THE “TRAWELL CO 2021-2024 WARRANT”

Therefore, there remain in circulation no. 3.681.039 Trawell Warrants that can be exercised continuously until December 16, 2024, as per the "Trawell Co 2021-2024 Warrant Regulation" ("Warrant Regulation"). As a result of the above, the new share capital of Trawell Co S.p.A. will be Euro 16.268.726,06, consisting of no. 2.518.711 ordinary shares without nominal value. The certification of the change in share capital will be filed with the competent register on March 1, 2024.
